

This Privacy Policy for personal data (hereinafter referred to as the Privacy Policy) applies to all information that OOO "I-Climate" located on the domain name: www.i-climate.ru can receive about the user while using the website of LLC "Ai- Climate".

DEFINITION OF TERMS

1.1. The following terms are used in this Privacy Policy:

1.1.1. "Administration of the site of OOO "I-Climate, (hereinafter referred to as the Site Administration) "- employees authorized to manage the site, acting on behalf of a group of legal entities that organize and (or) process personal data, and also determine the purposes of processing personal data, composition personal data to be processed, actions (operations) performed with personal data.

1.1.2. "Personal data" — any information relating directly or indirectly to a specific or identifiable individual (subject of personal data).

1.1.3. "Processing of personal data" — any action (operation) or a set of actions (operations) performed using automation tools or without using such tools with personal data, including collection, recording, systematization, accumulation, storage, clarification (update, change), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data.

1.1.4. "Confidentiality of personal data" is a mandatory requirement for the Operator or other person who has gained access to personal data to prevent their dissemination without the consent of the subject of personal data or other legal grounds.

1.1.5. "User of the site of OOO "I-Climate (hereinafter referred to as the User) "— a person who has access to the site through the Internet and uses the site of OOO "I-Climate ".

1.1.6. "Cookies" is a small piece of data sent by a web server and stored on a user's computer, which the web client or web browser sends to the web server each time in an HTTP request when trying to open the page of the corresponding site.

1.1.7. "IP-address" is a unique network address of a node in a computer network built using the IP protocol.

• GENERAL PROVISIONS

2.1. The User's use of the website of "I-Climate" means acceptance of this Policy confidentiality and the terms of processing the User's personal data.

2.2. In case of disagreement with the terms of the Privacy Policy, the User must stop using of the website of OOO "I-Climate".

2.3. This Privacy Policy applies to the website of OOO "I-Climate", and also to all its derivatives - all sites of the third domain level.

2.4. The site administration does not verify the accuracy of the personal data provided by a user of the site of OOO "I-Climate".

2.5. **Information from persons under the age of 14 is not accepted for processing.** If the User is under the age of 14, he has no right to enter his data on the site "I-Climate" or provide any personal information about himself. In the event that the Site Administration becomes aware of the receipt personal information from a person under the age of 14, she has the right to delete this data immediately.

• SUBJECT OF PRIVACY POLICY

3.1. This Privacy Policy establishes the obligations of the OOO "I-Climate" Site Administration for non-disclosure and ensuring the confidentiality protection of personal data that user provides to the Site Administration when filling out application forms or sending messages from the site.

3.2. The personal data permitted for processing under this Privacy Policy are provided by the User by filling out the application form on the website and include the following information:

3.2.1. Username;

3.2.2. User's contact phone number; 3.2.3. e-mail address (e-mail);

3.3. OOO "I-Climate" protects data that is automatically transmitted while viewing ad units and visiting pages where the statistical script of the system ("pixel") is installed:

- IP address;
- cookies information;
- information about the browser (or other program that provides access to display ads);
- access time;
- the address of the page on which the ad unit is located;
- referrer (address of the previous page).

3.3.1. Disabling cookies may result in inability to access parts of OOO "I-Climate" website network requiring authorization.

3.4. Any other personal information not specified above (browsers and operating systems used, etc.) is subject to secure storage and non-proliferation, except as provided in clauses 5.2. of this Privacy Policy.

• PURPOSES OF PERSONAL USER'S INFORMATION COLLECTING

4.1. "I-Climate" Administration may use Personal User's data in order to:

4.1.1. Establishing feedback with the User, including sending contact information regarding "I-Climate" website use, provision of services, processing of requests and applications from the User.

4.1.2. Confirmation of the User personal data accuracy and completeness.

4.1.3. Providing the User with effective customer and technical support in case of problems with the use of "I-Climate" site.

5. METHODS AND TERMS OF PERSONAL INFORMATION PROCESSING

5.1. The processing of the User's personal data is carried out without any time limit, in any legal way, including processing in personal data information systems with the use of automation tools or without them.

5.2. The User's personal data can be transferred to the authorized government bodies of the Russian Federation only on the grounds and in the manner established by the legislation of the Russian Federation.

5.4. In case of loss or disclosure of personal data, the Site Administration informs the User about the loss or disclosure of personal data.

5.5. The site administration takes the necessary organizational and technical measures to protect the User's personal information from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, as well as from other illegal actions of third parties.

5.6. The site administration, together with the User, takes all the necessary measures to prevent losses or other negative consequences caused by the loss or disclosure of the User's personal data.

• OBLIGATIONS OF THE PARTIES

6.1. The User is obliged:

6.1.1. Provide personal data necessary to use OOO "I-Climate" website.

6.1.2. Update, supplement personal data provided in the event of change by notifying OOO "I-Climate" Administration by e-mail: info@i-climate.ru or by phone: +7 (495) 638-53-84.

6.2. The site administration is obliged:

6.2.1. Use the information received solely for the purposes specified in clause 4 of this Privacy Policy.

6.2.2. Ensure that confidential information is kept secretly, not disclosed without the prior written permission of the User, and also not to sell, exchange, publish, or disclose in other possible ways the transferred User's personal data, with the exception of clauses cl. 5.2. of this Privacy Policy.

6.2.3. Take precautions to protect the confidentiality of the User's personal data in accordance with the procedure usually used to protect this kind of information in the existing business.

6.2.4. Block personal data related to the relevant User from the moment the User or his legal representative or the authorized body for the protection of the rights of personal data subjects apply or request for the verification period, in case of revealing inaccurate personal data or illegal actions.

• LIABILITY OF THE PARTIES

7.1. The Site Administration, which has not fulfilled its obligations, is liable for losses incurred by the User in connection with the unlawful use of personal data, in accordance with the legislation of the Russian Federation, with the exception of cases provided for in cl. 5.2. and 7.2. of this Privacy Policy.

7.2. In case of loss or disclosure of confidential information, the Site Administration is not responsible if this confidential information:

7.2.1. Became public domain before its loss or disclosure.

7.2.2. Was received from a third party until it was received by the Site Administration.

7.2.3. Was disclosed with the User's consent.

• DISPUTE RESOLUTION

8.1. Before going to court with a claim for disputes arising from the relationship between the User of OOO "I-Climate" site of and the Site Administration, it is mandatory to submit a claim (a written proposal for a voluntary settlement of the dispute).

8.2 The recipient of the claim within 30 calendar days from the date of the claim receipt shall notify the applicant of the claim in writing about the results of the claim consideration.

8.3. If an agreement is not reached, the dispute will be referred to a judicial authority in accordance with the current legislation of the Russian Federation.

8.4. The current legislation of the Russian Federation applies to this Privacy Policy and the relationship between the User and the Site Administration.

• **ADDITIONAL TERMS**

9.1. The site administration has the right to make changes to this Privacy Policy without User's consent.

9.2. The new Privacy Policy comes into force from the moment it is posted on the website of OOO "I-Climate ", unless otherwise provided by the new edition of the Privacy Policy.
